Conditions for Reproduction

1) Requests:

Chester County Historical Society (hereafter, CCHS) retains all rights to reproductions and publication in any form of items in its collections. 2) Permission:

Permission to reproduce covers only single edition, in one format, English language North American rights, copyrighted and published under the imprint of one publisher. Exclusive and serial rights are not granted. Supplemental editions being published and copyrighted by other publishers, whether in the same or in different languages or in an electronic format different from the format originally authorized and subsequent revised new editions will be considered upon application. Additional use of any kind, including reprints, further editions, etc. will require reapplication. Written permission must be received from Chester County Historical Society for each use of any photograph for publication or exhibition.
